## Notes on accounts SOCIETY FOR SOCIAL AUDIT ACCOUNTABILITY AND TRANSPARENCY Financial Year 2019-20

- The Society (SSAAT) was formed as per the decision of the Hon'ble Cabinet Committee, Government of Rajasthan, vide its Order no.49/2019 dated 27.06.2019 for carrying out Social Audit in the State.
- 2) We have been informed that the Society has received a sum of Rs 35 Lakhs from MGNREGA, GOR towards Social Audit work vide Office Order no F.21(39)/NAREGA Fund/2019-20/Part-2 Jaipur dated 07.01.2020. Interest earned on the above amount of Rs 20255/- is also credited back to State MGNREGA account. The total outstanding as on 31,03.2020 is Rs 35,20,255/-.
- 3) As per Order no M-11015/57/2019-MGNREGA (RE-III) (369892) SL no 19 of Government of India, Grant of Rs 13,51,33,000/- was sanctioned for conducting Social Audit in the state and staffing of Independent Social Audit unit for the Financial year 19-20 but since the amount was received on 28.07.2020 (Rs.1 Crore) and balance Rs 12,51,33,000 on Rs 15.01.2021, hence the Society has recorded this Grant as grant received in FY 2020-21, as SSAT is following accounting on cash receipt basis as per the State Government Rules which have been duly adopted by SSAAT.
- 4) The expenses incurred during this year (Rs. 51,318/-) have been done by SSAAT on account of MGNREGA, Government of India (GOI) and the Society has further informed that this expenditure would be charged on MGNERA, GOI, account from the grant to be received in next financial year. This would thus be accordingly shown by SSAT in the UC of MGNREGA, GOI, as excess spent for FY 19-20.
- The books of accounts are being prepared on historical cost basis and as a going concern.
- Accounting policies adopted to prepare books of accounts not referred to otherwise are consistent with generally accepted accounting principles.
